EXECUTIVE OVERVIEW

Peru is a major investment destination in South America, with a solid financial and monetary system in the region, which allowed for GDP1 growth in 2022 and has a BBB+ rating with a stable perspective.

The Autoridad para la Reconstrucción con Cambios - ARCC is a leading Peruvian public institution in the execution of projects and is in charge of implementing the Comprehensive Plan for Reconstruction with Change (PIRCC) to restore all physical infrastructure damaged and destroyed by the El Niño Coastal Phenomenon in 13 regions of Peru, as well as the implementation of prevention measures.

The ARCC has a Government to Government Agreement with the Department for International Trade of the Government of the United Kingdom of Great Britain and Northern Ireland that facilitates the role of executor of large-scale works such as the implementation of integrated solutions in rivers, streams and storm drains, with the support of the United Kingdom Delivery Team (UKDT).

What are we tendering for?

On 22 June 2023, the Roadshow event of the G2G Procurement process will take place, which will be broadcasted in Spanish and English through ARCC's institutional networks, such as Facebook and YouTube². This event will provide details of the procurement process for the pre-investment studies and design of the projects identified in the "Piura, Castilla and Veintiséis de Octubre Storm Drainage Plan" and in the "Comprehensive Plan for Flood Control and Mass Movement in the Piura River Basin"³, which include interventions in river defences, drainage, natural infrastructure and dams in the department of Piura.

What are the objectives of the Procura package?

The selection of a consultant to develop pre-investment studies at profile level + RIBA3 of three (3) Investment Projects (IP) for:



Pluvial drainage in the districts of Piura, Castilla and Veintiséis de Octubre;



Riverbank protection of the Piura River against the danger of flooding and erosion; and



Recovery of forest ecosystems in the upper basin of the Piura River.

The formulation of these studies will provide investment projects that will identify measures to reduce risk of flooding and mass movements to prevent and mitigate the impact of heavy rains and floods in Piura, also allowing for an adequate storm and river drainage system in the city, with the aim of reducing the risk of damage to the population, their livelihoods and the assets that provide public services.

These design works will be a milestone in the development of infrastructure in Northern Peru and will allow the progressive development of engineering works based on the investment projects carried out.

What Scope will the design have?



River defences + Dams: Engineering studies are required for the identification of flood containment infrastructure solutions.




Natural Infrastructure: Engineering studies are required for the identification of cost-efficient, resilient, sustainable, complementary and synergistic green and brown infrastructure intervention solutions in an intervention area covering approximately 10,000 hectares.



Drainage system: Engineering studies are required for the improvement and extension of the storm drainage service in the Piura, Castilla and Veintiséis de Octubre districts to mitigate the risk of storm flooding.















How will the procurement process be carried out?

The UKDT Team will be responsible for the development of this Procurement process under the application of the principles of fair, open and transparent in accordance with the Procurement Policies which are guided by international standards. The outline of the procurement process will have three (3) stages:

Mandatory Undertaking (MU);

Pre-qualification (PQQ); and

Invitation to tender (ITT).

The entire procurement process is carried out through the AWARD portal4. For new companies wishing to participate in our procurement processes, it is important to register their participation in the "Register of Interest" available on the web portal of the Autoridad para la Reconstrucción con Cambios - ARCC.
